GUIDELINES TO THE USE OF THE “LÍNEA EXPRÉS” SERVICE

Users who request the “Línea Exprés” service will be subject to the guidelines established and will assume the consequences derived from their violation.

1. Refrain from using the designated express lane with an expired service contract or do not have enough credit in your account balance to cover the toll.
2. Use only of the bridge you have contracted your service for.
3. The account holder is considered the “user” of the service and is the only person authorized to make any changes within and to the account.
4. In case of frequent errors in the automatic detection of the TAG by the antenna, the user must visit the Service Center to request the replacement of the TAG, additional costs may apply.
5. The user must know the TAG ID assigned to the vehicle and the TAG must remain attached on the center of the vehicle’s windshield, or on the license plate according to the type of the TAG, for it to be considered valid identification device.
6. If the TAG is intentionally and/or accidentally manipulated, the replacement will be at a cost to the user.
7. It is the user’s responsibility to request the removal of a TAG from his account, in case of a vehicle change, a windshield replacement, etc.
8. The money credit balance in the account is not refundable or can be transferred to another person. No payment made to the “Fideicomiso’s” bank account can be refunded, until it is legally authorized by the technical committee of this trust fund. All bank deposits, without exception, must be accredited in-person at the Service Center within the same month in which the deposit was made.
9. The user must respect the order of the line and avoid joining it arbitrarily.
10. The user is prohibited from slowing down the flow of traffic in the express lanes due to omission in the renewal of its service contract or an insufficient balance., including carrying out online payments on the lane, dropping off passengers, or making purchases from street vendors.
11. It is entirely the user’s responsibility to keep his or her information updated in the account.
12. At all times, the user must respect the staff of the Fideicomiso de Puentes Fronterizos de Chihuahua, including the security guards and the all the official government authorities.
13. In case of lane obstruction due to vehicle breakdown or a car accident, the user is responsible for moving the vehicle out of the confined lane as soon as possible.
14. The account holder will be held responsible for the improper use of the TAG and/or at express lane; therefore, he or she will be entitled to the definitive suspension of the service when a violation to the guidelines occurs by any of the TAGs or vehicles registered on the account.

I declare that all the information previously stated in this document is true and I recognize that if there are inconsistencies and/or falsehoods, my authorization as a user (including the cancelation of my TAG) will be invalidated; thus unable to use any “Línea Exprés” lane under the concession of the *Fideicomiso de Puentes Fronterizos de Chihuahua*.
